Hi Tristan,

It is not possible to get a backdated quote for travel. If a minimum business itinerary was not captured then yes, the state will only cover up to \$200 of the ticket. That said, if the agency believes there was error on the travel planner side or another justification you may approve full cost, but you will need to provide specific authorization from the division director or commissioner to attach to the travel closure form. SSOA will proceed at the \$200 without either an MBI or the special approval.

I was hoping I may inquire about the possibility of getting a backdated CTM quote. An individual is processing a trip for one of their travelers with a personal deviation and can't seem to track down a previously established MBI. If it isn't possible, would the below answer in the Travel FAQs still be in effect? Thank you!

04. If I had deviated travel and forgot to obtain a fare quote will I get reimbursed?

Effective on January 1, 2021, If the Traveler cannot produce a State-authorized fare quote, the Traveler will be eligible for a maximum allowance of \$200 for a round-trip or multi-destination itinerary or \$100 for a one-way itinerary. The state will reimburse the lesser amount of either the deviated ticket purchased or the predetermined allowance.

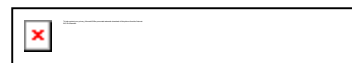

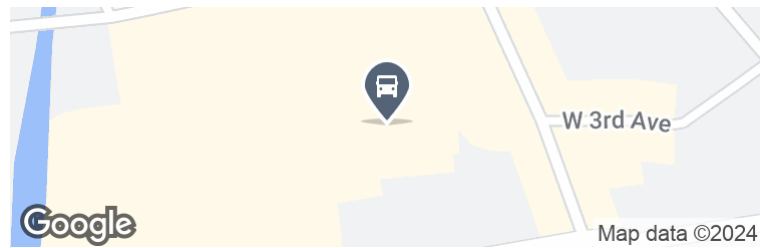
