COMPLAINT FOR DAMAGES

COMES NOW Plaintiff, Shoreside Petroleum, Inc., by and through undersigned counsel of record, and for its complaint against Defendants, Denali Disposal, Inc., Bernadette Wilson, and Roberta Zipay, hereby alleges as follows:

JURISDICTION AND VENUE

1. This Court has jurisdiction over this matter pursuant to AS 22.15.030(a)(1) as the amount claimed does not exceed \$100,000.

2. Venue is proper in the Third Judicial District pursuant to Alaska Civil Rule 3(e).

PARTIES

3. Shoreside Petroleum, Inc. ("Shoreside") is an Alaska corporation engaged in business in the State of Alaska and is duly authorized and competent to bring this action.

4. Upon information and belief, Bernadette Wilson ("Wilson") was and is at all times relevant hereto, a resident and citizen of the State of Alaska, residing in Anchorage, Alaska, and the President of Denali Disposal, Inc.

5. Upon information and belief, Roberta Zipay ("Zipay") was and is at all times relevant hereto, a resident and citizen of the State of Alaska, residing in Anchorage, Alaska, and the Secretary/Treasurer of Denali Disposal, Inc.

6. Upon information and belief, Denali Disposal, Inc. ("Denali") is an Alaska corporation authorized to conduct business in the State of Alaska. At all times relevant to the allegations of this Complaint, Denali was conducting business within the Third Judicial District of Alaska.

STATEMENT OF FACTS

7. This is an action to collect amounts owed to Shoreside by Denali.

8. On or about June 15, 2020, Wilson, on behalf of Denali as applicant, applied for commercial credit with Shoreside by completing a Commercial Credit Application. (Exhibit 1).

9. Contained within this credit application, and as a condition precedent to credit being granted to Denali, are terms creating personal liability obligating Wilson to make payment "if the debts incurred by the business entity are not paid." (Exhibit 1).

10. In reliance upon the representations made by Wilson in the credit application, including her agreement to personally guarantee Denali's obligations for any outstanding debt of the company owed to Shoreside, the credit application was accepted.

11. On or about March 31, 2022, and continuing through on or about July 31, 2022, Denali purchased petroleum products from Shoreside on credit.

12. Denali has failed to make timely payment for the petroleum products purchased and the account has now incurred the contractually agreed upon late fees and interest charges which continue to accrue. Additionally, the parties' agreement entitles Shoreside to recoup full attorney's fees and costs associated with the collection of this debt.

13. On August 31, 2022, Shoreside generated, and provided to Denali, a delinquent account statement for Denali in the aggregate amount of \$52,444.36, a copy of which is attached hereto as Exhibit 2.

14. Shoreside has made repeated demand for the account to be brought current. To date, neither Denali, Wilson nor Zipay have remitted payment to Shoreside for any portion of the outstanding balance.

WHEREFORE, Plaintiff Shoreside Petroleum, Inc., Inc. prays for the following relief:

1. For an award of money damages in favor of Plaintiff, Shoreside Petroleum, Inc., and against Defendants, Denali Disposal, Inc., Bernadette Wilson, and Roberta

Zipay, jointly and severally, in the amount of not less than \$52,444.36, the exact amount to be proven at trial;

2. For pre-judgment and post-judgment interest;

3. For costs and actual attorney's fees incurred in bringing and maintaining this action; and

4. For such other further relief as this Court deems just and equitable.

**MEMORANDUM IN SUPPORT OF
MOTION FOR ENTRY OF FINAL JUDGMENT**

COMES NOW Plaintiff Shoreside Petroleum, Inc. ("Shoreside"), by and through undersigned counsel, and hereby seeks entry of final judgment against Defendants, Denali Disposal, Inc., Bernadette Wilson, and Roberta Zipay, pursuant to Entry of Default by Clerk entered on December 6, 2022. Plaintiff also seeks an award of full reasonable attorney fees and costs incurred in the prosecution of its claims. A proposed order and proposed form of Final Judgment is submitted herewith.

I. INTRODUCTION

On October 5, 2022, Shoreside filed a complaint against Defendants Denali Disposal, Inc., Bernadette Wilson, and Roberta Zipay, (collectively "Denali Defendants") seeking to collect amounts owed to Shoreside by Denali Defendants for petroleum products purchased on credit by Denali Defendants in the amount of not less than \$52,444.36. Denali Defendants have failed to appear and answer or otherwise defend this action. On November 22, 2022, Shoreside made an Application for Entry of Default against Denali Defendants which was granted and issued on December 6, 2022.

II. DISCUSSION

Under these circumstances, it is appropriate for the Court to find Plaintiff the "prevailing party" as defined by Alaska law. A prevailing party determination is committed to the broad discretion of the trial court and will only be overturned for an abuse of discretion, such abuse being established only where it appears that the court's determination is manifestly unreasonable. *Wooten v. Hinton*, 202 P.3d 1148, 1155 (Alaska 2009). The test for determining which party is a prevailing party, as articulated in a plethora of Alaska Supreme Court cases, can be fairly summarized as the party which prevailed on the main liability question in the case. *Progressive Corp. v. Peter ex rel. Peter*, 195 P.3d 1083, 1092 (Alaska 2008); e.g., *Keenan v. Wade*, 182 P.3d 1099, 1109-1111 (Alaska 2008); *Day v. Moore*, 771 P.2d 436 (Alaska 1989) (per curiam); *Belluomi v. Fred Meyer Stores of Alaska, Inc.*, 993 P.2d 1009 (Alaska 1999).

Here, Shoreside put forth allegations and evidence to establish that a debt was incurred and that this debt was not satisfied prior to bringing the present action. Further, that the parties agreed to and contracted for certain benefits in the event that collection

of the debt became necessary, to wit: to pay interest at the highest available rate, and "to pay reasonable court and attorney fees in the event that collection by law becomes necessary."¹

III. CONCLUSION

Shoreside therefore respectfully requests that the Court enter a final judgment in its favor, and that Shoreside be permitted to recover full reasonable attorneys' fees and costs. A motion for attorney fees and costs is being filed separately.
